- Entries close on Saturday 20th April 2019
- Entry Fees must accompany Entry Form to be accepted
- ❖ All cattle must be the bona fide property of the Exhibitor for at least three (3) months prior to Show date
- ❖ All Exhibitors and passengers are required to pay Gate Admission unless the holder of a pass, Life Membership or Membership Ticket
- ❖ All Cattle are to be delivered to the Showgrounds on Friday 26th April 2019 by 4.00pm
- To be exhibited and judged on Saturday 27th April 2019
- Judging to commence at 9.00am
- Cattle will be fed overnight by the Show Society
- ❖ All Cattle will be purchased by Maclagan Meats and Oakey Beef Exports
- ❖ Grain, Grain Assisted and Grassfed will compete against each other
- ❖ Weighing of Cattle will be the responsibility of the owner
- ❖ The owner is responsible for identifying the beast, by inserting an Eartag with the Number (no name, number only) (this number will be supplied on acceptance of Entry by the Chief Steward) tag to be supplied by the owner
- ❖ All cattle to be tagged with an NLIS device
- The Chief Steward reserves the right to reject any entries that do not meet the market requirements



Goombungee-Haden A. H. & P. Society Inc Conditions of Entry

- 1. Gates will open to the public 8.00am on Show day.
- 2. Competitors shall endeavor to send a detailed list of articles they intend to submit for competition. Where possible the list should be delivered to the Secretary at least 3 days before the Show. Each Article on delivery should be correctly labelled with Section and Class details. Entry Fees should accompany each entry.
- 3. No discount on entry fees will be allowed other than the Membership Entitlement of 10% discount when fees are paid before the 1st March 2019.
- 4. Exhibits will be received in accordance with the regulations set out in this Schedule.
- 5. No exhibitor will be allowed to remove or in any way interfere with any exhibit until 5.00pm Show day, unless with permission from the Steward concerned or the Secretary.
- 6. Agricultural and Horticultural Produce and Home Cooking must be grown or made by the exhibitor.
- 7. The Judge may award a second or third place instead of a first, or may withhold a prize altogether, when the exhibits are not of sufficient merit.
- 8. Where exhibits bear the name of an exhibitor or manufacturer, the name is to be carefully covered until judging is over.

- 1. Gates will open to the public 8.00am on Show day.
- Competitors shall endeavor to send a detailed list of articles they intend to submit for competition. Where possible the list should be delivered to the Secretary at least 3 days before the Show. Each Article on delivery should be correctly labelled with Section and Class details. Entry Fees should accompany each entry.
- 3. No discount on entry fees will be allowed other than the Membership Entitlement of 10% discount when fees are paid before the 1st March 2019.
- 9. The Secretary reserves the right to refuse entry into the grounds, to any exhibit where there is reason to accept that it is diseased or dangerous. The Secretary also reserves the right to remove such an entry from the grounds.
- 10. No award ribbon, other than those awarded at the Show shall be placed on any exhibit whilst in the Showgrounds, without prior approval of the Steward for the section in which it is entered.
- 11. The committee shall abandon the Show, or any event contained therein, due to wet weather or any other reason which may make such course advisable. Should the show, or any event, be abandoned or cancelled then the exhibitor is entitled to a refund of any entry fees paid for those events not proceeded with. No cause for action, liability, or obligation shall be maintained or incurred because of the abandonment or cancellation.
- 12. No collectors will be allowed on the grounds except those authorized by the Committee. Any person infringing this regulation will be removed from the grounds.
- 13. A commission or rebate of 10% of all sales of exhibits effected by Auction or privately, before removal of same on the grounds shall be paid to the Society by the sellers for the benefit of General Funds no later than 14 days after the close of the Show.
- 14. Precautions will be taken to guard against fire and to protect the property of the Show, but the exhibits will not be insured at a cost to the Society.
- 15. The Society will not be responsible for any damage, accident, loss or mis-delivery which may be caused through, or by, any exhibit, competitive or non-competitive, and it shall be a condition of entry that the exhibitor shall hold the Society and it servants harmless and indemnified from and against legal action arising from such damages and the Society will not, under any circumstances, hold itself liable for any accidents on the grounds or premises.
- 16. No stock entry will be allowed into the grounds without a permit which may be inspected at any time.
- 17. All prize money is to be collected from the office on the day of the Show. All prize money that is not claimed within one month of the show will be returned to General Funds.
- 18. Pavilion Stewards will be in attendance from 8.00am on the Friday and alternative arrangements for early exhibits may be made by contacting the Chief Steward of the section.

QCAS General Rules

- 1. All Affiliated Queensland Shows are conducted subject to the rules of the Queensland Chamber of Agricultural Societies Inc, the constitution and rules if this Society and any other regulation, which appears within the Schedule for individual Sections of the Affiliated Show.
- 2. Should there be any conflict between the rules of the Queensland Chamber of Agricultural Societies Inc, the constitution of this Society and regulations appearing in any Schedule of this Society shall prevail.
- Affiliated Show Societies shall establish additional rules & regulations pertaining to individual Show requirements.
- 4. These Rules should be included in affiliate Show Society schedules where appropriate.
- 5. Show Societies choosing to operate their competitions under these rules must comply in total with all rules below and associated rules noted at paragraph six (6) below.
- 6. Associated with these rules are specific rules for inclusion in Show Schedules. The associated rules are:
 - a. General Horse Regulations
 - b. General Rules for Stud Beef & Dairy Cattle
 - c. General Rules for Poultry & Caged Birds
 - d. General Rules for Alpaca Competitions, and
 - e. QCAS Competition Rules.

Conduct of Competitors

- 7. The President, Steward and/or the Committee person in charge of any Section of an individual Show shall have the right to refuse any entry by an Exhibitor without expressing reason at any time up to commencement of judging of the Section to which it applies.
- 8. The Society reserves the right to refuse entry to any stallholder if the Society reasonably believes that it is necessary to do so in order to ensure that the standard, quality and safety of the Show is maintained.

- 9. The President, Chief Steward and/or the committee person in charge of any Section shall have the right to alter or amended the program or time of any event up to the commencement of judging.
- 10. An Affiliated Society will not under any circumstances hold itself liable for any accident, loss, damage or non-delivery of livestock or other exhibits at the Society's Show, and it shall be a condition of entry that each Exhibitor shall hold the Affiliated Society blameless and indemnify it against any legal proceedings arising through any accident, loss, non-delivery or damage whatsoever.
- 11. Exhibitors must obey all lawful orders of the President, Secretary, the Committee person in charge or the Steward of the Section in which the Exhibitor is entered. Failure to abide by any such order may incur a fine of an amount to be determined by the President of the Affiliated Society or on order of the President, the Exhibitor may be removed from the grounds together with the exhibit.
- 12. Chief Steward of an Affiliated Society shall have the power to remove Exhibitors or other persons from the vicinity of the Judge while judging. Preferably Shows should close off areas while judging is taking place, and only the Chief Steward, Judge and Stewards should be present.
- 13. The Judge's decision in any Section at an Affiliated Show will be final.
- 14. Any protest by an Exhibitor must be lodged in writing with the Committee person or Steward in charge of any Section within 30 minutes of the completion of the event together with a minimum fee of \$100.00 or as determined by the Committee of the Affiliated Society. The fee will be forfeited if the protest is frivolous or vexatious. The protest shall be heard according to the rules of the natural justice by a Dispute Committee of three (3) appointed by the President of the Affiliated Show and the decision of the Disputes Committee shall be final.
- 15. All persons causing a nuisance by loud comments or the decision of the Judges of otherwise unseemly behavior will, after being cautioned, be expelled from the Showgrounds, and in case of Exhibitors, be liable for disqualification.
- 16. Ribbons/Prizes will be awarded at the Judge's discretion notwithstanding that there may be provision in the schedule for the awarding of ribbons and prizes.
- 17. Exhibitors shall ensure that they and all animals are entered and Shown in the correct class BUT Stewards have the right to ensure exhibits are entered correctly.
- 18. All Exhibitors must present their exhibit for judging at the appointed time and place. Judging shall not be delayed for an Exhibitor who is not ready and the Committee person in charge or the Chief Steward of a Section shall have the right to exclude or disqualify the Exhibitor competing in the Section, who does not present on time.
- 19. If, in the opinion of the Committee person in charge of the Chief Steward of a Section, any animal or exhibit is entered in the wrong class, the Committee person in charge for the Steward of the Section shall have the power to enter the animal or exhibit in its correct class prior to the commencement of judging that class.
- 20. Where there is an age limit on an Exhibitor, or animal, any of the following shall be accepted as proof of age:
 - a. A birth certificate
 - b. A drivers license
 - c. A current passport
 - d. Current breed registration papers
- 21. Exhibitors must at all times, behave in a proper and courteous manner to Judges, Show Officials and other Exhibitors. Should an Exhibitor behave in an offensive or improper manner, the Committee person in charge or the Chief Steward in the Section shall have the right to, exclude and disqualify that Exhibitor from competing in the Section.
- 22. All Exhibitors and/or grooms entering the Showgrounds shall obey the lawful direction of the President, Committee, Stewards or employees of the Show Society, failure or refusal to do so, shall entitle the President of the Affiliated Society to disqualify the Exhibitor and/or his/her exhibit from competing at the Show and may order the removal of the Exhibitor and/or exhibit from the grounds.
- 23. A Judge shall not adjudicate at more than one Show, where practical within 60 days within a Sub-Chamber unless judging different Sections. This rule applies to all Affiliated Agricultural Show Sections.
- 24. Judging cards and performance records shall be completed by the Committee person in charge, Chief Steward and/or the Judge of a section (if required) during or immediately after the judging of the Section OR at the Judge's convenience.
- 25. Judges MUST be suitably attired when judging.
- 26. Competitors must be suitably attired when exhibiting. No personalised advertising to be displayed and Stewards Badges must be removed when parading animals before Judges. In stud rings, Dust Coats must be worn, or Breed Society approved uniform only.
- 27. If a Judge is unable to fulfill a judging commitment, the Judge shall notify the Show Society as soon as possible so a replacement can be arranged.
- 28. A Judge shall not send a substitute Judge. All invitations to Judge shall be sent by the Affiliated Society.

- 29. A Society shall report to the Queensland Chamber of Agricultural Societies Inc. any Judge who fails to attend a Show to which he or she has accepted an invitation to Judge or, who has failed to Judge at the time advertised for the commencement of the class provided that the failure to attend or appear is without reasonable cause.
- 30. A Judge may not officiate and compete or exhibit in the same Section and the same Show unless exceptional circumstances exist such as illness or unavailability of the appointed Judge.
- 31. An Exhibitor shall not compete in a Section if the Exhibitor is a member of the Judge's immediate family.
- 32. An Exhibitor shall not compete nor Show any animal in a Section if the animal has been owned or leased by the Judge or a member of the Judges immediate family.
- 33. An Exhibitor shall not compete if the Exhibitor or any animal being Shown by an Exhibitor has been given tuition by the Judge or the Judge's business partner within three (3) months prior to or during the Show.
- 34. An Exhibitor is ineligible to compete, if the Exhibitor has employed or has ever been employed by or been the business partner of the Judge of the Section within three (3) months prior to or during the holding of the Show.
- 35. A Judge shall not visit the livestock-housing complex if the Show Society, not the owners, nor inspect or discuss any animal entered in the Show prior to or during the judging of the relevant Section.
- 36. No Exhibitor shall deface or alter registration papers or performance cards of any exhibit.
- 37. A Judge or Steward must not knowingly permit an ineligible Exhibitor to compete.
- 38. No Exhibitor or member of the Exhibitor's immediate family or employed by the Exhibitor shall approach a Judge in regard to a decision made by the Judge unless they first obtain permission from the Committee person in charge or steward of the Section.
- 39. In Breed Classes, ALL animals must have current Registration and Ownership Certificates with the Breed Society.
- 40. In Breed Classes, registration papers (where applicable) must be available at the Show as proof of registration.
- 41. An Exhibitor required by the Show Section or rule of the Affiliated Society to parade an exhibit in the Grand Parade and who fails to do so, shall not be entitled to and shall forfeit any prize money or Trophy to that Exhibitor and / or for that exhibit.
- 42. The Exhibitor shall ensure that they and their exhibits comply at all times with all statutes, regulations and by-laws applying to the Affiliated Shows Showgrounds at the time of the Show including, but not limited to all animal health requirements.
- 43. Any Exhibitor, space holder or entertainer intending to bring electrical equipment onto the Affiliated Show Showgrounds will be required to ensure that such equipment is fitted with earth leak circuit breakers and that all electrical leads, tools and appliances have been inspected by a licensed electrical contractor and currently tagged by a licensed electrical contractor. This is essential for the safety of all Exhibitors and the general public and is a requirement of the current Electrical Safety Regulations. The use of double adaptors is prohibited, and all power boards must be tagged and tested.
- 44. Where an animal is being led, ridden, worked and displayed, it is the responsibility of the owner / handler / rider at the time to ensure the animal does not become a public safety liability.
- 45. Dogs, other than those owned by a member of the Canine Control Council, must be kept in a closed float, a vehicle, or on a short leash and must be suitably muzzled as to prevent it from being able to injure or bite any person or other animal, whilst on the Affiliated Society's Showgrounds.
- 46. Any competitor, who receives any physical or electronic communication aid during the judging of an event on the Affiliated Society's Showground, will have all nominations cancelled. The persons concerned may be asked to leave the Showground.
- 47. Energised electric fences are prohibited on the Showground at any time, unless in a specified area and suitably signed.
- 48. Rules for individual Section at any Affiliated Society's Show, shall be as per the attached schedule(s) and they shall be read in conjunction with the rules.
- 49. A Judge shall have no further information provided other than what is provided by the Affiliated Show Society.
- 50. No Judge, judging Handler or Parader classes is to ask the competitors to swap animals at Local Shows. This rule has been added in accordance with Workplace Health & Safety.
- 51. In all Affiliated Agricultural Shows Sections, Judges should not Judge the same Section within a three (3) year period at the same Show.
- 52. Whilst all reasonable care is taken, the Affiliated Society cannot accept any responsibility for any losses and or damage or injury to or by any livestock, exhibits, equipment, vehicles or any other property whilst it is on the Affiliated Society's Showground.
- 53. It is considered that good ethics if a Junior Judge or Associate has been judging in his / her own right at any Show, they are not eligible to enter the Young Judges competition at the Show, BUT they can still enter at another Show where they are not acting in a Judging role.
